The Annual Report on Grants provides Directors with a concise summary of all grants awarded in 2016 and offers a preview of program direction for the upcoming year. A quick review of 2016 program highlights follows below.

In 2016, The Overbrook Foundation's Environment and Human Rights Programs Awarded 96 Grants totaling \$4,137,500. Of those awards, 49 were grants awarded in the Environment Program, for a total of \$2,190,000, while 47 grants, totaling \$1,947,500 were awarded in the Human Rights Program. In the Environment Program, approximately three quarters of all grant dollars awarded were directed at Latin American Biodiversity Conservation, Behavioral Change and Movement Building. Corporate Practices was the next largest component with remaining funds awarded for Innovation, Food and the Environment and Other.

Dollars awarded for Human Rights Program grantmaking were divided among five separate initiatives: U.S. Gender Rights, domestic Human Rights, Money in Politics, International Human Rights Defenders and International Other. U. S. Gender Rights, International Human Rights Defenders and Money in Politics received about 80% of total awarded support in 2016. Domestic Human Rights received approximately 15% of awarded support with the remaining 4% going to International Other.

Funds awarded to the Environment and Human Rights Programs in 2016 reflect the decisions reached by the Board of Directors in 2015 and finalized in 2016 for the Foundation's Strategic Plan. The Environment Program had seven initiatives in varying stages of development during 2016 while the Human Rights Program had four active initiatives. At the beginning of 2017, the Board approved a new focus on mass incarceration and mass criminalization for the Foundation's domestic human rights initiative as the last component of the new Strategic Plan.

The Environment Program made several key changes in its staffing as the Foundation moved into 2017. Samantha Harvey, who in her role as Environment Program Officer focused on advancing the work of the Building Equity and Alignment (BEA-I) Initiative and Movement Building, left the Foundation at the end of 2016 and has now embedded her work in the grassroots environment community. Alex DeMucha, Environment Program Assistant, accepted a position at Earthjustice where she will continue to grow her career as an environmental activist. Samantha and Alex are missed and their replacements have big shoes to fill.


Joining the Foundation in 2017 are: Catherine "Katie" Gwathmey as Environment Program Assistant and Benjamin "Benji" Jones as Environment Program Associate. Both have impressive resumes for individuals so early in their careers.

Sarah Abelow, Human Rights Program Officer and Stephen Foster, the Foundation's President continue to jointly oversee the Human Rights Program. Beginning to build a portfolio of grants around mass criminalization and mass incarceration will be a key piece of their work in 2017.


All program staff are engaged in launching the Foundation's newest initiative, The Overbrook Fund Supporting Coalition Building, Resistance, Organizing and Litigation. The Fund is designed to support innovative strategies building stronger coalitions and movements, mobilizing people to organize resistance and engaging in litigation that challenges attacks on human rights and the environment. Staff is working closely with other funders to increase the pool of funds available to support these resistance efforts for more effective and helpful grantmaking in this pivotal moment.

Human Rights Grants Awarded 2016




In 2016, The Overbrook Foundation's Environment and Human Rights Programs Awarded 96 Grants Totaling \$4,137,500.


There were 49 grants awarded in the Environment Program, for a total of \$2,190,000.

The Human Rights Program: Grants Awarded in 2016



In 2016, Overbrook's human rights grantmaking focused on three programmatic initiatives. Internationally, the Foundation funded organizations that defend human rights defenders at risk in Central America and Mexico. These groups provide legal assistance, training, emergency grants, advocacy, accompaniment, networks and/or psychosocial support to human rights defenders. Domestically, the Foundation funds organizations challenging the undue influence of moneyed interests in the U.S. political system. These organizations are working to make our government and policy makers more accountable to the people by reforming the role of money in our political system. The Foundation's gender rights program supports organizations working across reproductive justice and LGBT rights issues. This includes a focus on funding organizations advancing the reproductive justice movement and those challenging overly broad religious exemptions being used to undermine LGBT rights, racial justice and reproductive justice. Finally, the Foundation is exploring a newer area of grantmaking around challenging mass criminalization and incarceration, and advancing human rights, building on Overbrook's long term support for organizations strengthening a U.S. human rights movement. This initiative remains in development.


